

## 17 counties, 1 city receive bridge funds

Seventeen counties and one city have been awarded a total of \$8.1 million by the Kansas Department of Transportation for replacement of bridges.

KDOT received 63 applications requesting \$30 million in funding under the Federal-Aid Off-System Bridge Program for federal fiscal year 2017, which will begin on Oct. 1, 2016.

By federal law, a state must allocate an amount of Federal Surface Transportation Program funds, equal to no less than 15 percent of the federal bridge funds it received in 2009, for bridges not on the federal-aid system. To comply, KDOT established the Federal-Aid Off-System Bridge Program.

Under the program, recipients can receive up to \$1 million and must provide matching funds in the amount of 20 percent.

The only city to receive funding is Winfield. Counties selected for funding include Anderson, Brown, Chase, Clay, Coffey, Comanche, Elk, Ellis, Ellsworth, Greenwood, Norton, Osage, Osborne, Pottawatomie, Rush, Shawnee and Wilson.
