KDOT announces approved July bids

The Kansas Department of Transportation announces approved bids for state highway construction and maintenance projects. The letting took place July 21, 2021, in Topeka. Some of the bids may include multiple projects that have been bundled based on proximity and type of work.

District One — Northeast

Douglas - 59-23 KA-5794-01 - U.S. 59, at three locations beginning 300 feet south of the N 1200 Road intersection, north approximately 0.6 mile, guard fence, 0.6 mile, Bettis Asphalt & Construction Inc., Topeka, Kansas, \$220,531.48.
