KDOT announces approved July bids

The Kansas Department of Transportation announces approved bids for state highway construction and maintenance projects. The letting took place July 19, 2023, in Topeka. Some of the bids may include multiple projects that have been bundled based on proximity and type of work.

District One — Northeast

Lyon - 99-56 KA-6991-01 - K-99, from K-170/K-99 junction north to U.S. 56/K-99 junction, sealing, 9.1 miles, Vance Brothers Inc. and Subsidiary, Kansas City, Missouri, \$434,222.72.

Shawnee - 470-89 KA-5766-01 - I-470, bridge #046 located 0.2 mile northwest of 10th Street, bridge replacement, A M Cohron & Son Inc., Atlantic, Iowa, \$7,691,334.98.

Statewide - 170-106 KA-6988-01 – K-170; from the junction K-99/K-170 east to the Lyon/Osage county line in Lyon County, sealing, and from the Osage/Lyon county line east to the south city limits of Osage City in Osage County, sealing, 21.4 miles, Vance Brothers Inc. and Subsidiary, Kansas City, Missouri, \$1,088,973.36.

District Two — North Central

Statewide - 106 KA-7127-01 – U.S. 81, from the Ottawa/Cloud county line north to Eagle Road; I-135 from the Saline/McPherson county line north to the U.S. 40/I-70/I-135 junction, rumble strip installation, 23.9 miles, Surface Preparation Technologies LLC, New Kingstown, Pennsylvania, \$105,255.00.

District Three — Northwest

Norton - 60-69 KA-7000-01 - K-60, from the U.S. 36/K-60 junction north to the end of K-60, sealing, 4.3 miles, APAC-Kansas Inc. Shears Division, Hutchinson, Kansas, \$187,992.33.

Osborne - 281-71 KA-7004-01 – U.S. 281, from the County Road 412/U.S. 281 junction

north to the south city limits of Osborne, sealing, 16 miles, Circle C Paving and Construction LLC, Goddard, Kansas, \$597,578.39.

Sherman - 91 KA-7058-01 - Comfort station, along I-70 by the city of Goodland at the K-27/I-70/U.S. 24B junction and the Road 21/I-70/U.S. 24B junction, special, McCormick Excavation & Paving LLC, Stratton, Colorado, \$393,526.00.

District Five — South Central

Harvey - 15-40 KA-6997-01 - K-15, from the north city limits of Newton north to the Harvey/Marion county line, sealing, 7.6 miles, Circle C Paving and Construction LLC, Goddard, Kansas, \$358,066.63.

Kingman - 14-48 KA-6922-01 - K-14, from the K-42/K-14 junction north to the south city limits of Kingman, crack repair, 12.1 miles, Pavement Pro's LLC, McPherson, Kansas, \$105,454.70.

Reno - 50-78 KA-6790-01 - U.S. 50, light towers located north of U.S. 50 0.2 mile and east of Scott Boulevard, lighting, 0.7 mile, Phillips Southern Electric Company Inc., Wichita, Kansas, \$245,849.00.

Rice - 4-80 KA-6916-01 - K-4, from the Barton/Rice county line east to the Rice/Ellsworth county line, crack repair, 25.4 miles, Pavement Pro's LLC, McPherson, Kansas, \$228,196.58.

Sedgwick - 54-87 KA-6179-01 - U.S. 54, in Wichita between West Street and Armour Street, intelligent transportation system, 7.7 miles, Phillips Southern Electric Company Inc., Wichita, Kansas, \$2,344,716.00.

Sedgwick - 54-87 KA-6770-01 - U.S. 54, bridge #132 located 0.2 mile east of Hoover Road, bridge repair, Wildcat Construction Co. Inc. & Subsidiaries, Wichita, Kansas, \$1,178,719.00.

Sedgwick - 235-87 KA-6918-01 - I-235, from the I-235/I-135 junction in Wichita north to North Broadway Street, pavement marking, 15.6 miles, Century Fence Co., Pewaukee, Wisconsin, \$1,684,404.60.

Sedgwick - 96-87 KA-7060-01 - K-96, from 0.7 mile east of Webb Road to the north approaches of bridges over U.S. 54, 4-inch overlay, 4.6 miles, Pearson Construction LLC, Wichita, Kansas, \$7,272,379.23.

Sumner - 81-96 KA-6921-01 - U.S. 81, from 2.5 miles north of RS 645 north to the south city limits of Wellington, and from the north city limits of Wellington north to the Sumner/Sedgwick county line, crack repair, 18.9 miles, Pavement Pro's LLC, McPherson, Kansas, \$145,776.07.

Statewide - 83-106 KA-6234-01 – U.S. 83, from the U.S. 83/U.S. 50/U.S. 400 junction in Garden City north to the I-70/U.S. 83 junction in Thomas County, ITS, 89.5 miles, Ideatek Telcom, Buhler, Kansas, \$7,551,442.40.
