KDOT announces approved January bids

The Kansas Department of Transportation announces approved bids for state highway construction and maintenance projects. The letting took place Jan. 17, 2024, in Topeka. Some of the bids may include multiple projects that have been bundled based on proximity and type of work.

District One — Northeast

Leavenworth - 73-52 KA-7131-01 – U.S. 73, from 0.06 mile south of Ida Street north to Limit Street, ultra-thin bonded asphalt surfacing, 2.7 miles, Ideker Incorporated, Saint Joseph, Missouri, \$2,216,347.57.

Leavenworth - 52 N-0733-01 – Basehor, Parallel Road from 158th Street to 155th Street, 158th Street from Garden Parkway to Parallel Road, trail section between 158th Street and 155th Street south of Parallel Road along Metrogreen Corridor, pedestrian and bicycle paths, 1.0 mile, Miles Excavating, Inc., Basehor, Kansas, \$2,439,300.76.
