KDOT announces approved June low bids

The Kansas Department of Transportation today announced approved bids for state highway construction and maintenance projects in Kansas. The letting was held June 20, 2012 in Topeka.

District One - Northeast

District One – Signing Improvements on U.S. 36, K-87, K-110, K-178, K-187, K-236, K-120, K-136, and K-238, 110.1 miles, Fulsom Brothers, Inc., Cedar Vale, \$578,663.10.

Douglas-Johnson – K-10 in Douglas County near Eudora and the K-10/K-7 junction in Johnson County, cable median barrier, 4 miles, Gray Beal Construction Co., Topeka, \$1,158,713.85.

Johnson – I-35 and 75th Street, lighting, 0.2 mile, Total Electric Contractors, Inc., Edwardsville, \$232,927.
