The Kansas Department of Transportation today announced approved bids for state highway construction and maintenance projects in Kansas. The letting was held July 18, 2012 in Topeka.

KDOT announces approved July low bids

District One - Northeast

District – Mudjacking in 11 District One counties, Nortex Concrete Lift and Stabilization, Inc., Fort Worth, Texas, \$201,312.50.

Leavenworth – U.S. 73 from 320 feet south of the north junction of K-92 northwest to 0.4 mile north of Leavenworth, 2.8 miles, asphalt surfacing, Superior Bowen Asphalt Co., Inc., Kansas City, Mo., \$537,190.64.

Lyon – I-35 from the east end of the bridge over U.S. 50 north and east to the Lyon-Coffey county line, overlay, 10.3 miles, APAC Kansas, Inc., Shears Division, Hutchinson, \$2,798,418.26.
