## **U.S. 40 Kansas River Bridges Repair Project to Begin in Douglas County – UPDATE!**

On **Monday, April 15**, a repair project will begin on the northbound and southbound U.S. 40 Bridges over the Kansas River in downtown Lawrence (Douglas County). Crews will complete repairs on the bridge bearings followed by painting work on the repaired areas. Work will take primarily underneath the bridge deck with no restricted times/days as to when crews will complete repair work on the project.

Beginning at **9:00 a.m. on Monday, April 15**, northbound and southbound U.S. 40 over the Kansas River Bridges will be reduced to one lane each direction for the duration of the project. Traffic will be directed through the project work zone via signage and cones. Drivers should expect significant delays during peak commute times and may wish to use alternate routes, if possible. There will be a posted speed limit of 25 mph and a 12-foot lane width restriction through the project work zone at all times. No oversized or supersized loads will be allowed through the project work zone. *(Due to the forecasted wet weather for this upcoming week, the project start date has been rescheduled from Monday, April 9 to Monday, April 15.)*

all motorists to be alert, obey the warning signs, and “Give ‘Em a Brake!” when approaching and driving through the project work zone.

PCI Roads (Saint Michael, MN) is the primary contractor on this \$150,000 bridge repair project. **Project work is scheduled to be completed by mid-June 2013, weather permitting.**
