US-75 Resurfacing Project to Begin in Shawnee County – **UPDATE!**

On Wednesday, September 19, a resurfacing project will begin on a 2.75-mile stretch of US-75 from the Soldier Creek Bridge (north of US-24) to I-70 in Shawnee County. Project work includes spray patching for pavement repair and a 3-inch asphalt overlay followed by all new pavement markings. The resurfacing project will smooth the road and fill surface defects that can shorten pavement life. (Due to scheduling conflicts, the project start date has been moved from Tuesday, September 11 to Wednesday, September 19.)

Work will take place during specified hours, Monday through Sunday. Northbound US-75 will be reduced to one lane from 7:00 p.m. to 3:30 p.m. the following day and all northbound lanes will be open to unrestricted traffic from 3:30 p.m. to 7:00 p.m. each day. Southbound US-75 will be reduced to one lane from 9:00 a.m. to 6:00 a.m. the following day and all southbound lanes will be open to unrestricted traffic from 6:00 a.m. to 9:00 a.m. each day.

On Wednesday-Friday, September 19-21, northbound and southbound will have varying lane closures as crews complete spray patch work on pothole areas via a mobile operation. Then beginning on Monday, September 24, northbound and/or southbound will be reduced to one lane for overlay work. Traffic will be directed through the project work zone via message boards, cones and signage. There will be a posted speed limit of 55 mph and a 14-foot lane width restriction through the project work zone

The Kansas Department of Transportation urges all motorists to be alert, obey the warning signs, and "Give 'Em a Brake!" when approaching and driving through the project work zone.

Bettis Asphalt and Construction Inc. (Topeka, KS) is the primary contractor on this resurfacing project with a total contract cost of \$3.584 million. **The scheduled completion date for the project is mid-November 2012, weather permitting.**
