## US-24 Resurfacing Project to Now Begin in Shawnee County – UPDATE #2!

On **Tuesday**, **May 22 at 7:30 a.m.**, a resurfacing project will begin on a 7.4-mile section of US-24 from approximately 800-feet west of the city limits of Silver Lake to the Menoken Road Bridge just west of Topeka in Shawnee County. Project work includes patching, milling away of 2-inches of existing pavement followed by an inlay of new asphalt pavement. After the patching work is complete, the project will go into suspension until mid-summer 2012, when the mill and inlay operation will begin. A separate notification will be sent in advance of the start date.

Beginning on **Tuesday**, **May 22 at 7:30 a.m. for approximately two weeks**, eastbound and westbound US-24 traffic will be reduced to one lane for both directions along with intermittent closures of adjacent cross roads during the project work hours for patching work. Traffic will be directed through the project work zone via flaggers. There will be a posted speed limit of 55 mph through the project work zone during working hours. There will be a 14' lane width restriction as well.

Work will take place during daylight hours from 7:30 a.m. to 7:30 p.m., Monday through Friday, with some occasional Saturday work. Signage will direct drivers through the project work zone. Drivers should expect major delays during peak travel times and are encouraged to use alternate routes, if possible. **Special Note:** This

## project will also run consecutively with the two US-24 bridge replacement projects currently underway in Shawnee County.

Bettis Asphalt and Construction, Inc. (Topeka, KS) is the primary contractor on this resurfacing project with a total contract cost of \$1.454 million. The scheduled completion date for the entire resurfacing project is late summer 2012, weather permitting.
