
Recreational Trails



RECREATIONAL TRAILS PROGRAM

With the authorization of MAP-21 the Recreational Trails (RT) program and several other separately funded programs were merged into one new program the Transportation Alternatives Program (TA). The RT program for funding is a set-aside of TA. As such a portion of the State of Kansas TA funds equal to the funding amount the state of Kansas received for RT apportionment in 2009 must be used for recreational trails with 1% of the funds being returned to FHWA for administration of the RT program. Funds set aside from the TA program for RT are available for a three year period from the last day of the fiscal year for which funds were authorized. The RT requirements and provisions under section 206 of title 23 remain in effect including the requirement for 40 percent diverse use, 30 percent motorized use and 30 percent non-motorized funding use.

In the state of Kansas at the authority of the Governor, administration of the RT program lies with the Kansas Department of Wildlife, Parks and Tourism (KDWP&T). Since RT projects are not under the administration of KDOT, the RT projects are not included in Appendixes A-D of this document. Instead, RT projects and associated funding anticipated in the Federal Fiscal Years 2015-

2018 STIP are listed on the following page. The funding estimated for each of these projects is based upon the funding guidelines outlined in MAP-21. For planning purposes the years subsequent to FFY 2014, FFY 2015-2018 are all estimated at the FFY 2014 level. All RT projects are funded based on an 80 percent federal and 20 percent state (KDWP&T) or local match.
