RECREATIONAL TRAILS PROGRAM

With the authorization of the FAST Act, the projects and set asides covered under TAP including recreational trails (RT) are now funded by the Transportation Alternatives (TA) set aside of the Surface Transportation Block Grant (STBG) program. Under the FAST Act, the amount of federal funding reserved for the Recreational Trails program (RTP) remains unchanged. For RTP a portion of the State of Kansas TA set aside funds equal to the funding that the state of Kansas received for the RTP apportionment in 2009 must be set aside for recreational trails with 1% of the funds being returned to FHWA for administration of the RTP. For the four years of this STIP the amount is anticipated to be \$1.37 M for each year.

The RTP program provides funds to develop and maintain recreational trails and trail related facilities for both motorized and non-motorized trail uses. The requirements and provisions under section 206 of title 23 remain in effect including the funding ratio requirement that 40 percent of funds be delegated for diverse use, 30 percent for motorized recreation use and 30 percent for non-motorized recreation use when making project selections.

In Kansas at the authority of the

Governor, administration of the recreational trails program is the responsibility of the Kansas Department of Wildlife, Parks and Tourism (KDWP&T). Since RTP projects are not under the administration of KDOT, the RTP projects are not included in Appendixes A-D of this document. Instead, RTP master projects for the Federal Fiscal Years 2017-2020 STIP are listed on the following pages. The funding estimated for each of these projects is based upon the funding guidelines outlined in the FAST Act. All RT projects are funded based upon an 80 percent federal funds and 20 percent state (KDWP&T) or local match.
