

#### Why Manufacturing Matters

Manufacturing provides high-wage jobs and is a critical part of the economic base in many metropolitan areas. More metropolitan areas specialize in manufacturing today than 30 years ago.








# KANSAS TRANSPORTATION AND CROP MAP

Highways






### KANSAS TRANSPORTATION AND CROP MAP Railroads




### WATERWAYS
